- **What is Brave Foundation?**

Brave Foundation is an Australian Not for Profit Registered Charity that is registered as a Deductible Gift Recipient, this means that you can claim your donation on your tax. Brave Foundation builds up the village of acceptance and support around expecting and parenting teens with resources, referral and education opportunities to facilitate happy, healthy and skilled families over time

- **Where do the funds raised from fundraising go?**

The funds raised from fundraising will help Brave Foundation continue its support services for parenting teens and funding Brave Foundation's National Education Awareness campaign, scholarships and triage service. As a non for profit organisation we rely on the generosity of supporters to help fund these initiatives.

HOSTING A FUNDRAISING EVENT

- **How do I register to host a fundraising event?**

Registration is easy, please visit the registration page on the website, once you have registered you can create your own personal online fundraising page where you can share and invite your friends to your shower or to donate.

- **How do I organise a fundraising event?**

Hosting a Brave Fundraising event is easy with our Resources section and host pack. Pick a date, venue, theme and fundraising goal. Set up your fundraising page and send us the details so we can assist you in promoting your fundraising event.

- **Do I receive a Host pack?**

Once you have registered to host a shower, you can download all the resources required from the website.

- **I want to advertise my fundraising event. Can you help me advertise?**

FUNDRAISING

- **How do I collect donations from my guests?**

1. Once registered, you can set up your personal online fundraising page where you can invite your guests to donate online prior to your event.
2. On the day an idea is having a donation centrepiece, such as a plant, that has clips on it. Encourage guests to place notes on the plant as leaves, to donate to your fundraising event.
Set up a donations box, and place it in an obvious (and secure) place. Tell everyone on the invitation it is either a gold coin or a paper note donation to attend.
3. Come up with creative and unique ways of collecting donations from your guests. Please let us know, we would love to hear your ideas!
4. Dollar Matching – ask your employer to match the funds you raise. Download our dollar matching template.

We recommend trying to collect donations prior to your event and at your event, but please ensure it is easy for your guests to give.

FUNDRAISING

- **How do I pay/bank the funds I raise for Brave Foundation?**
 1. You can bank the funds you raised via your online fundraising page
 2. Read the information supplied in your host pack that provides banking instructions
 3. Bank the funds into your account and then donate online via our online donations page
- **Does Brave Foundation provide tax receipts for donations?**
 - Donations over \$2.00 are tax deductible. If you set up your online fundraising page, you will be able to provide automatic tax receipts for your guests
 - Alternately you can fill out the Donations Tally Sheet in the Resources section on the website and we will send your guests electronic tax receipts.
- **Do you accept donations from overseas?**

Yes we do, direct them to your online fundraising page where they can donate. They will need to check with a financial advisor in their country to see if their donation is tax-deductible.
